

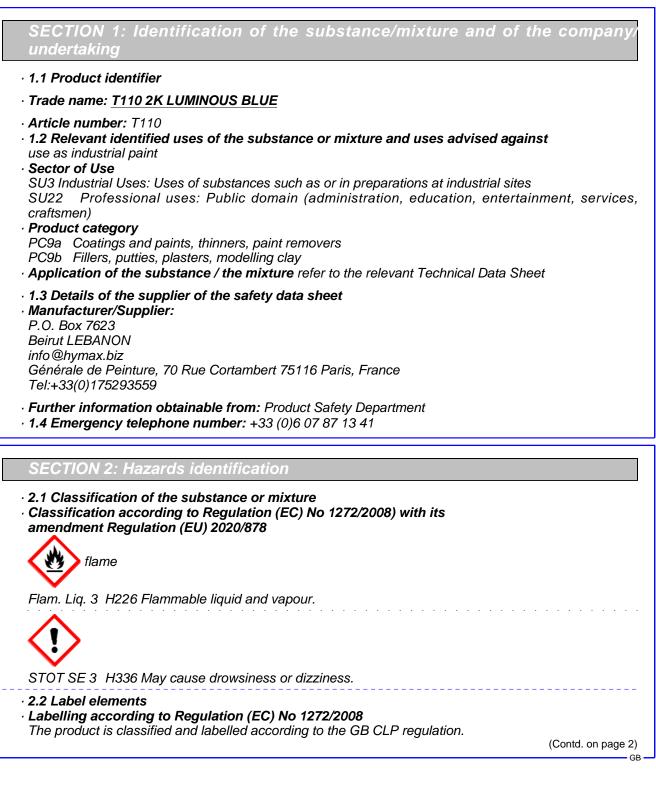

Protective gloves
